Most of our requests for assistance come in a fee-based technical assistance requests. We try and turn those around in 60 days, given our resources and workload. Our staff presently have 70+ open sites that they are working on, in addition to the closed sites that are coming in for redevelopment assistance. Further, many of these staff work on federal grant sites that have deadlines that we need to meet.

Thanks Joe. Hello also Darsi and Judy.

Based on reports submitted to DNR, the Dane County Truax Landfill south of the airport has had VOC detections (PCE, TCE, VC) above the PAL and/or ES since the late 1980s (if not earlier). The former Burke Sewage Treatment plant (now Reyco property) is just south of the landfill and received a VI letter in 2011.

There are businesses, homes, and a Montessori pre-school adjacent to this landfill. It is hard to say if there is off-site migration, or a vapor risk, due to the limited number and limited depths of monitoring wells. Perhaps I am missing something.

Darsi or Judy, can you clarify whether or not the DNR assessed the potential for vapor intrusion at/near this site?

Ms. Powell,

The department's Waste and Materials Management program provides regulatory oversight for routine groundwater monitoring that is associated with licensed landfills. Landfill owners are required to notify the department if there are any detections of VOCs above a Preventative Action Limit or an Enforcement Standard in groundwater monitoring wells around the site. If groundwater impacts associated with a landfill are detected at levels that present a vapor risk and there is off-site migration, then the Waste & Materials Management program would be working closely with other DNR programs including the Remediation & Redevelopment and the Drinking and Groundwater Programs to determine the appropriate regulatory authority that would apply to the situation, including who is required to send notification letters. The vapor screening criteria in RR-800 would be used to guide decisions on whether VOCs in groundwater are a potential vapor risk to receptors. Residences and schools would be considered as would other occupied buildings or future development sites. Because landfill owners generally have routine monitoring and reporting requirements, there typically wouldn't be a case where vapor intrusion notification letters would be required to be sent to a landfill.

Do DNR landfill site managers (or someone else?) send VI letters to landfill owners if there are

VOCs at the landfill? Do they consider residences/schools, etc near landfills?

If the potential for vapor intrusion is a result of volatile contamination from the landfill, the approach to screen, sample, and interrupt the vapor intrusion pathway are addressed in guidance document RR-800, which is found on the program's vapor intrusion webpage: http://dnr.wi.gov/topic/Brownfields/Vapor.html.
